Your submission will be reviewed internally by GESIS Panel.dbd staff. Field experiments are welcome and are not limited to four experimental groups. Total survey time should not exceed 5 minutes per questionnaire module.







The following General Terms and Conditions apply:

### Non-commercial usage

- The GESIS Panel does not accept any commercial data collection projects.
- Data collected within the GESIS Panel may be used for (non-commercial) scientific purposes only. Any partially or fully commercial usage is prohibited.

### **Data protection**

- GESIS Leibniz Institute for the Social Sciences and all commissioned service providers work according to the regulations of the EU General Data Protection Regulation. Further, all statutory data protection provisions of the Federal Republic of Germany apply.
- Any attempt to de-anonymize data that is, to try to identify individual respondents is a criminal offense.
- Please note, that the GESIS Panel.dbd does not submit modules to an ethics board. If authors need a formal ethics statement, they should submit the proposal to a board of their choosing before sending it to the GESIS Panel.dbd.

- All proposals will undergo an internal review. Furthermore, we reserve the right to send proposals to external peer-reviewers.

- As GESIS Panel.dbd surveys are fielded in German, all questionnaire modules must be submitted in German.

### Style guide GESIS Panel.dbd

The GESIS Panel.dbd Digital Behavioral Data Sample is a pure online panel. Following the methodological principles of a unified mode design, the questionnaire should appear as similar as possible on all devices to maximize cross-sectional and longitudinal comparability. The layout of the GESIS Panel.dbd is designed for the device with the most restrictions, which is a smartphone with a small vertical display and touchscreen. This mobile-first layout strategy means that the question types and scale directions in the GESIS Panel.dbd are generally limited to vertical scales and an item-by-item question design.

- When designing your questionnaire module please consider the following points: As a matter of principle, we do not force respondents to provide an answer. Moreover, they may skip a question without further probing.
- A "back" button is included by default.
- A "don't know" category is not offered by default. However, it may be included if it is a substantive answer (e.g., in the case of knowledge questions) or if the researcher has other reasons for including it (e.g., comparability; for details of implementation).
- In general, we use one to three questions per page. More questions per page reduce the readability of the mobile-first layout.
- Underlining should be used for emphasis, if needed.
- Randomization of questions and items are possible. Random assignment of respondents to experimental groups is possible. Particularly elaborate designs must be coordinated with the GESIS Panel.dbd team in terms of feasibility.
- Plausibility checks are possible.
- Inclusion of multimedia elements is possible.
- Scales with less than six points must be fully labeled.
