The following General Terms and Conditions apply:

Non-commercial usage

- The GESIS Panel does not accept any commercial data collection projects.
- Data collected within the GESIS Panel may be used for (non-commercial) scientific purposes only. Any partially or fully commercial usage is prohibited.

Data protection

- GESIS Leibniz Institute for the Social Sciences and all commissioned service providers work according to the regulations of the EU General Data Protection Regulation. Further, all statutory data protection provisions of the Federal Republic of Germany apply.
- Any attempt to de-anonymize data that is, to try to identify individual respondents is a criminal offense.
- Please note, that the GESIS Panel.pop does not submit modules to an ethics board. If authors need a formal ethics statement, they should submit the proposal to a board of their choosing before sending it to the GESIS Panel.pop.
